MAYOR CORNELIUS HUFF CALLED THE MEETING TO ORDER.

FREEDOM OF INFORMATION STATEMENT WAS READ BY MAYOR HUFF CONCERNING NOTIFICATION OF THIS MEETING.

COUNCILMEMBERS MELVIN FOWLER, KEVIN NEWMAN, HEATHER MOORE AND KATHY DITTEMORE WERE PRESENT.

COUNCILMEMBER FOWLER MADE A MOTION TO APPROVE THE AGENDA, SECOND TO THE MOTION WAS MADE BY COUNCILMEMBER MOORE, MOTION CARRIED WITH ALL VOTING.

CITY ADMINISTRATOR JOE LANAHAN STATED THAT FOR THE CITY OF INMAN FISCAL YEAR 2021-2022 BUDGET THAT IN THE GENERAL FUND THERE ARE NEW LINE ITEMS WHICH ARE: AN ECONOMIC DEVELOPMENT POSITION; PALMETTO EAP- PALMETTO EMPLOYEE ASSISTANCE PROGRAM; ARCHIVESOCIAL-ARCHIVING SOCIAL MEDIA TECHNOLOGY; ZONING ADMINISTRATOR SALARY TO BE INCREASED AND WILL WORK 20 HOURS PER WEEK IN HOUSE; A THREE (3) PERCENT SALARY INCREASE FOR ALL EMPLOYEES AND A MILLAGE INCREASE OF 2.06 FOR A TOTAL OF 78.26 MILLAGE RATE.

IN THE SEWER DEPARTMENT A REQUEST FOR A NEW CRANE TRUCK AND IN THE HOSPITALITY TAX FUND THE NEW LINE ITEMS ARE: HOLMES PLAZA; JEFF BAILEY MEMORIAL FISHING TOURNAMENT AND EVENTS.

THE CITY ADMINISTRATOR WILL LOOK INTO FINANCING OPTIONS TO PAY FOR THE CAPITAL IMPROVEMENT PROJECTS INSTEAD OF PAYING FOR THEM ALL AT ONE TIME.
