MAYOR CORNELIUS HUFF CALLED THE MEETING TO ORDER.

FREEDOM OF INFORMATION STATEMENT WAS READ BY MAYOR HUFF CONCERNING NOTIFICATION OF THIS MEETING.

COUNCILMEMBER MELVIN FOWLER, KEVIN NEWMAN, HEATHER MOORE AND KATHY DITTEMORE WERE PRESENT.

COUNCILMEMBER FOWLER MADE A MOTION TO APPROVE THE AGENDA, SECOND TO THE MOTION WAS MADE BY COUNCILMEMBER MOORE, MOTION CARRIED WITH ALL VOTING.

AT 7:01 PM COUNCILMEMBER DITTEMORE MADE A MOTION TO GO INTO EXECUTIVE SESSION FOR DISCUSSION OF EMPLOYMENT, APPOINTMENT, COMPENSATION, PROMOTION, DEMOTION, DISCIPLINE, OR RELEASE OF AN EMPLOYEE, SECOND TO THE MOTION WAS MADE BY COUNCILMEMBER FOWLER, MOTION CARRIED WITH ALL VOTING.

AT 8:00 PM COUNCILMEMBER MOORE MADE A MOTION TO GO OUT OF EXECUTIVE SESSION AND BACK INTO THE SPECIAL MEETING, SECOND TO THE MOTION WAS MADE BY COUNCILMEMBER FOWLER, MOTION CARRIED WITH ALL VOTING.

MAYOR HUFF MADE A MOTION TO AMEND OUR GENERAL BUDGET FUND FOR 2022-2023 TO INCREASE REVENUE IN LICENSES & PERMITS BY \$105,004 AND TO INCREASE ADMINISTRATION SALARIES, FICA, RETIREMENT BY \$11,217; POLICE SALARIES, FICA, RETIREMENT BY \$60,491; STREETS SALARIES, FICA, RETIREMENT BY \$12,796; FIRE SALARIES, FICA, RETIREMENT BY \$20,050 FOR A TOTAL OF \$105,004 AND RETROACTIVE TO JULY 1, 2022, SECOND TO THE MOTION WAS MADE BY COUNCILMEMBER FOWLER. COUNCILMEMBER NEMMAN MADE A MOTION TO AMEND THE PREVIOUS MOTION MADE BY MAYOR HUFF THAT WAS SECONDED TO GIVE THE CITY ADMINISTRATOR ABILITY TO BRING MR. HALL'S SALARY UP TO \$39,000, SECOND TO THE MOTION WAS MADE BY MAYOR HUFF, MOTION CARRIED WITH ALL VOTING.
